I, **ELAINE HARTLE** Secretary of Mission Trace Homeowners Association (the "Association"), do hereby certify that at a meeting of the Board of Directors of the Association (the "Board") duly called and held on the **15** day of **Tanuary**, 2019, with at least a quorum of the Board members being present and remaining throughout, and being duly authorized to transact business, the following Assessment Collection and Fees Policy was duly approved by a majority vote of the members of the Board:

WHEREAS, Mission Trace Homeowners Association ("Association") is a residential community in Bexar County, Texas; and

WHEREAS, the Declaration of Covenants, Conditions and Restrictions applicable to Mission Trace was recorded in the Official Public Records of Real Property of Bexar County, Texas on in 1973 under Volume 6991, Page 193 and has been added to and amended on multiple occasions (collectively, "Declaration"); and

WHEREAS, Article X, Section 1 of the Declaration provides that the Association has the right to enforce all restrictions, conditions, covenants, reservations, liens, and charges imposed by the Declaration; and

WHEREAS, Article IV Section 6 of the Declaration provides that assessments may be collected on a monthly or quarterly basis as prescribed by the Board of Directors ("Board") of the Association; and

WHEREAS, due the increased cost to process payments monthly, the Board finds it is in the best interest of the community to require payment of assessments on a quarterly basis and, further, to impose a handling fees for monthly payments; and

WHEREAS, to encourage prompt payment of assessments, the Board desires to impose late fees for failure to pay assessments in a timely manner.

NOW THEREFORE, the Board hereby adopts the following policy related to assessment collection and fees.

- 1. <u>Quarterly Payments</u>. Assessments must be paid in advance on a quarterly basis. Quarterly payments are due on January 1, April 1, July 1, and October 1 each year.
- 2. <u>Late Fees</u>. Quarterly payments not received on or before the 10th day of the month in which they are due are delinquent. An owner who is delinquent will be charged a late fee of \$25.00 per month.
- 3. <u>Collection Costs.</u> An owner who pays assessments monthly instead of quarterly will be charged a \$10.00 handling fee for each monthly payment.
